TIDC and the Malaysian Panel-Products Manufacturers' Association (MPMA) signed a Memorandum of Understanding (MoU) to promote collaboration and knowledge sharing for sustainable planted forest management practices within the Licence for Planted Forests (LPF/0043) project.

The MoU, signed by STIDC's General Manager, Haji Zainal Abidin Bin Haji Abdullah and MPMA's Chairman, Datuk Wira Sheikh Othman Rahman, aims to strengthen the collaboration

between the two organisations in the field of sustainable industrial tree planting (ITP) activities, timber management operations, and Sustainable Forest management (SFM) practices.

Both STIDC and MPMA acknowledge the growing need for SFM practices as well as the importance of research and development (R&D) in the timber industry.

The MoU paves the way for the two organisations to work together and share their expertise and knowledge in these areas, ultimately leading to the growth and development of the Malaysian timber industry.

Haji Zainal, stated that the MoU

signifies a collaborative commitment between the two parties to promote knowledge enrichment and talent enhancement within the timber industry particularly in Sarawak.

"For STIDC, this MoU presents an opportunity to benefit from the extensive experience of the Peninsular Malaysia in the timber sector. In 2022, the exports of Malaysian timber and timber products increased by 10.6 percent to RM25.2 billion, marking the highest earnings recorded by the timber industry in recent years.

"Besides, the MoU provides a platform for STIDC to engage in collaboration with MPMA regarding on-the-job training and placement in the timber industry in the Peninsular Malaysia, aligning with the national goal of automation and transformation for the timber industry.

"This includes automation, advancement towards Industrial Revolution 4.0 (IR4.0), and the adoption of green and circular

economy practices. Moreover, it will foster the development of local talent in the timber industry and reduce reliance on manual foreign labour," he said.

Meanwhile, Datuk Wira added that SFM is crucial for the longterm growth of the timber industry.

"We are excited to work together with STIDC in this endeavour and contribute to the development of the industry. This MoU marks a significant step towards strengthening our collaboration and knowledge sharing in sustainable timber management practices." he stressed.

Under this MoU, STIDC and MPMA will collaborate on

various initiatives such as joint research studies, training, and capacity building programmes and sharing of best practices in sustainable industrial tree planting and timber management operations.

Thus, the partnership between STIDC and MPMA is poised to promote sustainability and innovation in the timber industry, further reinforcing Malaysia's position as a global leader in sustainable timber management.

MPMA Explored Sustainable Forestry Projects with STIDC

TIDC hosted a field visit for delegates from the Malaysian Panel Manufacture Association (MPMA) showcasing the best practices in managing planted forests at Sarawak's largest planted forest project, LPF/0043 in Bintulu.

The visit aimed to bolster collaboration between both entities and other MPMA members. This partnership between STIDC and MPMA was set to foster sustainability and innovation in the timber industry, further solidifying Malaysia's global leadership in sustainable timber management.

During the visit, Datuk Wira Sheikh Othman Rahman, Chairman of MPMA, expressed his keen interest in the LPF/0043 project. He hailed it as the association's prime choice for tropical tree cultivation, essential for the timber industry's product manufacturing. He remarked, "Touring this silviculture initiative, which I believe was the largest nursery in Malaysia, Southeast Asia, or any other part of the world I have visited, left an indelible impression. It stood as the optimal solution for us in sourcing tropical trees for plywood, chipboard, and furniture wood production. We earnestly hoped STIDC could help us in establishing a nursery in Peninsula Malaysia."

Delegates received comprehensive briefings on planted forest management and LPF/0043's best practices. Exploring

Research and Development (R&D) plots provided insights into innovative practices. Witnessing field operations for planting and harvesting reflected their commitment to responsible forest practices.

Moreover, delegates visited STIDC's bamboo trial plot at Sabal, Simunjan. They observed ongoing research and development efforts in bamboo cultivation and its potential impact on Sarawak's economic growth. This immersive experience demonstrated STIDC's dedication to advancing holistic sustainable ecosystems, fostering social inclusivity, environmental sustainability, and economic prosperity.

Representing more than 25 members, including Forest Research Institute Malaysia (FRIM), Malaysian Timber Industry Board (MTIB), and Malaysian Timber Council (MTC), the Chairman conveyed gratitude for STIDC's commendable efforts. He expressed a desire for closer collaboration and knowledge sharing, foreseeing mutual benefits.

Through collaborative endeavours, both organisations envisioned propelling the industry forward, establishing best practices, and nurturing continuous growth. Partnerships were crucial in sustainable industrial tree planting activities, timber management operations, and practices.



The visit centred on effective enforcement strategies and the necessary steps to comply with the EU Deforestation-Free Regulation (EUDR), set to be enforced effective 30th December 2024. Additionally, the delegation toured several timber companies in Kuching to acquire insights into industry practices.





STIDC Facilitates Brainstorming Session on Policy for Establishment of Mills in LPF Areas and Use of Mobile Equipment and Facilities



TIDC recently concluded a comprehensive two-day Brainstorming Session aimed at formulating crucial policies regarding the establishment of mills in Licensed Planted Forest (LPF) areas and the utilisation of mobile equipment and facilities.

The session delved into the direction details of these policies, recognising their pivotal role in shaping the timber industry's trajectory towards vibrancy and sustainability.

STIDC's General Manager, Haji Zainal Abidin Bin Haji Abdullah emphasized the significant impact these policies will have on Sarawak's economic growth, as well as their contribution to the broader Malaysian economy.

"We envisage these policies not only as catalysts for industry development but also as instruments for social inclusivity, ensuring the welfare of Sarawak's populace and forest workers in LPF areas.

"Moreover, our commitment to environmental sustainability remains unwavering, with mechanisms in place to safeguard our ecosystem." he said.

Highlighting the benefits of establishing mills in LPF areas, Haji Zainal underscored the potential for increased production and downstream processing efficiency, leading to resource optimisation and cost reduction.

Additionally, the adoption of a circular economy approach aims to minimise waste and maximise resource utilisation, aligning with global sustainability goals.

"The proposed policies align seamlessly with Sarawak's strategic objectives, including the ambitious target of achieving one million hectares of planted forest by 2025 and generating RM8 billion in annual exports from timber and timber products by 2030 under the Post-Covid-19 Development Strategy 2030 (PCDS2030).

"In pursuit of economic prosperity,

social inclusivity, and environmental sustainability, STIDC invites collaboration from stakeholders across various sectors. The collective efforts of government agencies, industry players, and environmental bodies are integral in realising a sustainable future for Sarawak's timber industry," he stressed.

Participating agencies during the session included the Ministry of Natural Resources and Urban Development (MUDeNR), Ministry of International Trade, Industry, and Investment Sarawak (MINTRED), Forest Department Sarawak, Land and Survey Department Sarawak, Natural Resources and Environment Board Sarawak, Department of Environment Sarawak, Sarawak Timber Association, Harwood Timber Sdn Bhd, and Sarawak Planted Forest Sdn Bhd.
















