STIDC Subscribes To Forest Management Certification

orest certification is a confirmation of compliance of forest management practices with an agreed set of rules expressed in form of Principles Criteria, Indicators and Management Specifications. It gives recognition to forest managers complying with international standards and best practices of responsible management and give fair treatment to

the local people. Forest certification also serves to

inform end users that they are buying the products

from sustainably managed forests. Certified timber products can fetch price premium and gain access into markets closed to non-certified timber products.

Forest certification is in line with Sarawak's commitment towards sustainable forest management. Through this initiative the state aims to project its positive image by combating illegal logging and promoting environmental protection and good governance. To the timber industry, forest certification is the way forward to secure bigger market share.

The forest management certification scheme is recognised internationally particularly by Forest Stewardship Coulcil (FSC) or Programme for the Endorsement of Forest Certification (PEFC) schemes or Malaysian Timber Certification Scheme (MTCS). Certification under any other scheme should be approved by the Director of Forest.

STIDC being the state government agency responsible to spearhead the advancement of the timber industry in Sarawak supports the forest management certification and hopes industry players will strive for the success of this initiative in order to gain greater customers' confidence and acceptance on our timber products.





STLVS certificate of compliance for mill operations and export

arawak is practising Sarawak
Timber Legality Verification System
(STLVS) covering the process
of licensing, harvesting, transporting,
manufacturing and trading of logs and
timber products in accordance with the
existing laws, regulations and procedures
governing forests and timber trade.

Legality is defined as "logs harvested by licensed persons from approved areas and verified by the relevant authorities in accordance with the laws, regulations and procedures pertaining to forestry and trade in Sarawak".

The system has undergone the process of improvement and enhancement in meeting the current needs.

In 2015, the STLVS was further enhanced to allow independent auditing and verification to be conducted by an independent third party.

This was followed by a seminar on STLVS in Tokyo and Osaka, Japan in 2016. The tireless efforts finally paid off and STIDC is now ready to issue the Sarawak Timber Legality Verification System (STLVS)

Certificate of Compliance for Principle 5

(Mill Operations) and Principle 6 (Trade & Export) and Export to the timber manufacturing mills and companies doing export and import activities in Sarawak.

Before issuing these certificates, the companies are to conduct the third party audit on its processes to ensure compliance to the STLVS Standard.

Briefings were conducted in Kuching, Sibu, Bintulu and Miri to enlighten the industry on STLVS Certificate of Compliance.

"This will add credibility and boost customers' confidence in export of Sarawak timber products worldwide", Datu Haji Sarudu Haji Hoklai, General Manager of STIDC said.

He added that STIDC, under the purview of the Ministry of Urban Development and Natural Resource, together with the other implementing agencies will intensify the promotion of STLVS in the main markets of Sarawak timber internationally.



Ministry encourages more firms to obtain timber certification

he Ministry of Plantation Industries and Commodities is encouraging more Malaysian companies to obtain timber certification to ensure all timber products are manufactured from sustainable sources and certified in compliance with stringent standards.

Its Minister, Datuk Seri Mah Siew Keong, said this was not only to conserve resources but also to continue accessibility to market demanding sustainable products.

"The timber sector is one of the important contributors to our national economy. It contributed RM21.86 billion to the country's export earnings in 2016. It also continues to take Malaysia to the global level through its ranking as one of the world's top exporters of tropical timber products," he told reporters after

presenting the Chain of Custody (CoC)
Certification to Royal Selangor International
Sdn. Bhd. The CoC is under the Malaysian
Timber Certification Scheme (MTCS).

The MTCS is a national timber certification scheme for sustainability developed and operated by the Malaysian Timber Certification Council (MTCC) to confirm the timber products manufactured or traded are sourced from sustainably managed forests.

The Corporation also attained 5-Star Rating based on Accountability Index 2016

TIDC attained 5-Star Rating and emerged the overall champion among the Sarawak Government Ministries, Departments and Agencies for Excellent Financial Management based on Accountability Index 2016 by the National Audit Department.

The rating aimed to benchmark the accountability and integrity of CEOs/Controlling Officers in financial management to ensure compliance to SOP. Accountability Index is part of KPI to assess financial management of the ministries, departments and agencies.

The rating also enabled CEOs/Controlling Officers to know their financial management status whether excellent (5-Star), good (4-Star), satisfactory (3-Star), less satisfactory (2-Star) or unsatisfactory (1-Star).



Excellent financial management entails the combined elements of:

- (i) excellent leadership;
- (ii) excellent organisational control;
- (iii) wise use of ICT;
- (iv) good information management systems:
- (v) competent human capital; and
- (vi) excellent work culture.

The audit session focused on nine main control aspects namely Organisational Management Control, Budget Control, Receipt Control, Expenditure and Revenue Control, Management of Trust Funds/ Trust Accounts and Deposit, Asset and Inventory Management, Investment Management, Loan Management and Financial Statement.

Sofa Engineering

Course The course covered several technical aspects of furniture engineering

TIDC in collaboration with Universiti Putra Malaysia (UPM) conducted a study on the wood-based Small and Medium Entrepreneurs (SMEs) in Sarawak. The study revealed that SMEs constitute 76% of the total number of manufacturing and services in the timber industry in Sarawak. They also account for 26% of the total installed capacity for timber products manufacturing and services and provide employment to 6.5% of the total workforce in the timber sector.

STIDC plays pivotal role in the development of SMEs through the Bumiputera Furniture Vendor Programme. Commenced in October 2002, the programme aims to create resilient community of Bumiputera entrepreneurs with emphasis on furniture and furniture related businesses.

Presently, there are 43 active Bumiputera furniture vendors across Sarawak. To ensure the success of this programme, STIDC provides the basic infrastructure such as workshops apart from trainings to help them to penetrate and compete with the global players.

In tandem with this aspiration, STIDC jointly organised sofa engineering course with the Furniture Industry Technology Centre (FITEC) on 24-28 July 2017 at STIDC Furniture Industrial Complex, Kota Samarahan.


The course covered several technical aspects such as making sofa framework, shaping sponge, identifying the right fabric, sewing the fabric and finishing.

Course Facilitator, Mohd. Idham Bin Saadon, said, the startup capital for sofa making business is approximately RM6,000.00 to buy the required tools including industrial sewing machine, walking foot sewing machine, mitre saw, stapler, spray gun, jig saw, rubber foam cutter, air screw driver, L-Square and metal ruler.

The five-day course was attended by STIDC furniture vendors and staff.

TIDC in collaboration with the Furniture Industry Technology Centre (FITEC) organised the Vehicle Cushion Making Course on 7-11 August 2017 at STIDC Furniture Industrial Complex, Kota Samarahan. The

course was attended by STIDC furniture vendors and staff.

The course focused on various technical aspects including making and replacing vehicle seat case, replacing door panel

lining, making and installing car palate, replacing carpet, replacing dashboard cover and making and wrapping car steering.

Course Facilitator, Mohd. Idham Bin Saadon, said, there were several steps to make vehicle cushion such as uninstalling and segregating the seat from backrest, removing and marking seat case to the new seat case template, sewing the new seat case, gluing the new seat case with laminated sponge, sewing the circumference of the new seat case and putting on the new seat case to the seat.

He added that the materials required were wrapping items such as fabric, PVC, polyurethane, skin, 4/6/8/10/12 mm laminated sponge, piping and threads.

Among the tools required were air-compressor, industrial sewing machine, stapler gun, ring pliers, jig saw, C Hock Bits, Air/Neumatic Hock Ring Machine spray gun, U-Tecker Gun, air nailer gun, L-Square and metal ruler.

OSH Campaign Augurs Well With Forest Certification

Initiative

ccupational Safety and Healthy (OSH) is an integral part of our lives. It warrants serious attention by all parties including the government, employers and employees. Occupational accidents and disasters particularly those that caused fatality pose adverse impacts to the affected parties. For employers, fatal accidents result in loss of talents and skills which affect productivity and tarnish reputation. For employees, fatal accidents cause loss of loved ones and sources of income.

Department of Occupational Safety and Health (DOSH) recorded 88 OSH cases for the period of January-July last year in the wood-based sector in Sarawak with eight fatalities, five permanent disabilities, 71 non-permanent disabilities and four dangerous occurrences. Consistent efforts by DOSH and STIDC in promoting OSH has brought the OSH cases down to 54 for the period of January-July this year, with one fatality, two permanent disability and 51 non-permanent disabilities.

Recognising the importance of OSH, STIDC in collaboration with DOSH and Sarawak Timber Association (STA) organised the OSH Campaign on 13-14 September 2017 at Berkakap Camp, Nanga Gaat to cater for wood-based companies in Kapit Division.

It was a continuation of last year's campaigns which were carried out across the state to create a culture of OSH at workplaces. The campaign focused on ground inspection to assess safety practices in the forestry sector including risks associated with driving along logging



roads and engineering activities as well as biological and psychological hazards.

The campaign also discussed topics on Occupational Safety and Health Act 1994 (OSHA); Hazard Identification, Risk Assessment and Risk Control (HIRARC); Occupational Safety and Health Committee at Workplaces; Notification of Accident, Dangerous Occurrence, Occupational Poisoning and Occupational Disease Regulation 2004 (NADOPOD) and Use and Standard of Exposure of Chemicals Hazardous to Health (USECHH Regulation).

Through this initiative, it is hoped that there would be local wood-based companies nominated in future and won the OSH Excellence Awards for greater customers' confidence and acceptance as well as to create benchmark for wood-based sector in Sarawak.

"Forest certification is crucial in the forestry sector. Under this initiative, safety and health of employees is a prerequisite to get forest concessions certified. It is therefore, vital to view certification and OSH seriously in order to comply with the global market requirements" STIDC General Manager, Datu Sarudu Haji Hoklai said.

To prevent occupational accidents, he emphasised that organisations must be aware of the hazards at workplaces and manage employees' safety and health effectively. Apart from employers, employees are equally responsible for OSH by making it a culture.

"Tripartite co-operation among the government, employers and employees on OSH should be intensified. All policies, strategies and programmes related to OSH warrant undivided support from the three parties in order to achieve the desired results" Datu Sarudu added.

The campaign was participated by camp managers, supervisors, foremen, scalers, surveyors, mechanics, fellers and drivers.

Export Value of Logs & Timber Products

Sarawak experienced a weaker export value of timber and timber products for the first half of 2017 by 0.5% to RM3.1 billion against the corresponding period in 2016.

This was attributed by the decrease in export value of moulding (2%), veneer (9%), particleboard (9%), logs (18%), laminated board/flooring (22%), woodchips (33%) and dowel (49%). Other timber products, however, posted higher export value including block board (100%), plywood (7%), fibreboard (7%) and sawn timber (6%). **(Table 1)**



Logs

The export volume of logs dropped by 8.97% to 1.2 million m³. Similarly, export value also dropped by 17.89% to RM639 million over the previous corresponding period.

Export quantity to Indonesia and Vietnam grew by 38% (to 580,206 m³ from 420,018 m³) and 1% (to 61,080 m³ from 38,040 m³) respectively. Export to India, however, decreased by 33% to 466,329 m³ from 695,562 m³.

The FOB price of logs decreased by 9% to RM531 per m³ from RM589 per m³ for the first half of 2016. **(Table 2)**





Plywood

Export of plywood for the first half of 2017 increased by 4.28% to 903,470 m³ compared to 866,384 m³ for the same period last year.

Export to Japan and Korea increased by 9% to 536,304 m³ and 16% to 124,011 m³ respectively. The Middle East, however, reduced consumption by 16% to 96,491 m³.

The FOB price of plywood increased by 3% to RM1,785 per m³ from RM1,740 per m³ during the same period last year.

Other Timber products



During the period, weaker export volumes were recorded for veneer (9%), particle board (9%), moulding (10%), laminated board/flooring (26%), woodchips (33%) and dowel (47%).

Growth, however, were recorded for block board (100%) and fibreboard (4%). (Table 5, 6, 7, 8, 9 & 10)



Timber companies in Sarawak are poised to experience weaker earnings due to the revised premium for hill timber from RM0.80 to RM50 per cubic metre effective 1 July 2017.

The State is looking at RM200 million to RM300 million collection under the new rate compared to RM15 million presently. Collection of the premium, which has remained unchanged since 1986, would be channelled to the Sarawak Foundation Fund, managed by Sarawak Foundation to finance excellent students for tertiary education, including in top foreign universities.

The research house said, it would result in higher cost of production of around RM49.20 per cubic metre for hill logging.



EXPORT VALUE (%) OF LOGS TO MAJOR DESTINATIONS



EXPORT VALUE (%) OF SAWN-TIMBER TO MAJOR DESTINATIONS



EXPORT VALUE (%) OF PLYWOOD TO MAJOR DESTINATIONS








EXPORT VALUE OF MOULDING TO MAJOR DESTINATIONS



EXPORT VALUE OF DOWEL TO MAJOR DESTINATIONS



EXPORT VALUE OF FIBREBOARD TO MAJOR DESTINATIONS





